

THE INTRINSIC DANCING WOMAN IN RED SWEEPSTAKES
OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM THE PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.

The Intrinsic Dancing Woman in Red Sweepstakes ("Sweepstakes") is sponsored by Ste. Michelle Wine Estates Ltd. ("Sponsor"), 14111 NE 145th Street, Woodinville, WA 98072, and is administered by Prize Logic, LLC ("Administrator"), 25200 Telegraph Road, Suite 405, Southfield, MI 48033.

- 1. SWEEPSTAKES PERIOD:** The Sweepstakes begins on November 1, 2018 at 12:00 PM Eastern Time ("ET") and ends on December 31, 2018 at 11:59:59 PM ET ("Sweepstakes Period"). Sponsor's computer is the Sweepstakes official clock.
- 2. ELIGIBILITY:** This Sweepstakes is offered only to legal residents of the fifty (50) United States and District of Columbia who are at least twenty-one (21) years of age at the time of entry. Employees, contractors, directors, officers, and agents of Sponsor, Administrator, and each of their respective parent companies, divisions, dealers, affiliates, subsidiaries, distributors, advertising and promotional agencies and suppliers involved in the Sweepstakes ("Sweepstakes Entities"), as well as the members of each of their immediate families (spouse, parents, children, siblings, and in-laws) and persons residing in the same household as such individuals are not eligible to enter or win. Void where prohibited or restricted by law.

Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions and interpretations, which are final and binding in all matters related to the Sweepstakes.

Compose a new Tweet or Instagram post sharing the video or picture on, including the hashtag "#ArtofRedSweepstakes" (include @intrinsicwineco for Instagram posts) or post the video or picture in the comment section on Facebook in response to Sponsor's post about the Sweepstakes including the hashtag "#ArtofRedSweepstakes" to receive one (1) Entry into the Sweepstakes.

The content included in the Entry will not be judged or used in any way to determine the winner. By entering the Sweepstakes and using the hashtag “#ArtofRedSweepstakes”, entrant hereby agrees to be bound by these Official Rules. Entries will be deemed made by the authorized account holder of the Twitter or Instagram account the entry is submitted from at the time of entry. The “authorized account holder” is the person who is assigned to the Twitter account or Instagram by the online service provider. An entrant must have a non-private Twitter account or Instagram account to enter the Sweepstakes and must be a follower of @intrinsicwineco on the platform used to enter until January 31, 2019 for potential winner notification purposes to be eligible to win/claim the prize. An entrant can create a Facebook account at no cost by visiting www.facebook.com. Each entrant specifically agrees to release Facebook from any and all liability associated with this Sweepstakes. RANDOM DRAWING: On or about January 2, 2019 Sponsor's representatives, whose decisions are final and binding on all matters relating to this Sweepstakes, will randomly select one (1) potential winner, provided a sufficient number of entries are received, from among all eligible Entries received. The winner is considered a potential winner pending verification of his/her eligibility and compliance with these Official Rules.

5. PRIZE, APPROXIMATE RETAIL VALUE, AND ODDS OF WINNING:

- A. Prize (1):** The winner will receive a trip for two (2) to Austin, Texas (“Prize”). Trip includes round-trip coach class air transportation from a major commercial airport near winner’s residence to Austin, Texas for winner and one (1) adult guest (age twenty-one [21] or older); two (2) nights hotel standard accommodations (single room/double occupancy); ground transportation to and from the airport and hotel; two (2) tickets to a music festival; and a \$500 check (for winner only). The approximate retail value (“ARV”) of the Prize is \$7,187.55. Only one (1) Prize will be available in the Sweepstakes. Winner’s guest must be twenty-one (21) years of age or older. The potential winner will be notified by a Direct Message from @intrinsicwineco on Twitter, Instagram, or Facebook with instructions on how to claim the Prize. The potential winner must respond to the Direct Message winner notification within twenty-four (24) hours or may, at the Sponsor's sole discretion, be disqualified. The potential winner will be required to sign and return an Affidavit of Eligibility and Liability/Publicity Release (except where prohibited) and any other requested documents within five (5) calendar days from the date of attempted notification or the Prize may be forfeited in its entirety and awarded to an alternate winner, at the Sponsor's sole and absolute discretion. Failure to provide all required information within the stated time period may result in forfeiture of potential winner's right to claim his/her Prize, and may result in the Prize being awarded to an alternate winner, if time permits. Prize is not transferable and includes only the items specifically listed as part of the Prize. Any portion of the Prize not accepted by winner will be forfeited. The winner shall be solely responsible for payment of any and all applicable federal, state, and local taxes for the Prize won. Sponsor will issue an IRS Form 1099-MISC for the winner. ARVs are as of the time these Official Rules were printed and the value of the Prize may fluctuate. The winner is not entitled to any difference between the ARV and the actual value of the Prize at the time the Prize is awarded. All other costs and expenses not expressly set forth herein shall be solely the winner's responsibility. The Prize will only be awarded to a verified winner.

ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN OAKLAND COUNTY, MICHIGAN. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING BUT NOT LIMITED TO ATTORNEYS’ FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF. ENTRANTS AGREE THAT THE RIGHTS AND OBLIGATIONS OF ANY ENTRANT AND/OR SWEEPSTAKES ENTITIES AND/OR ANY OTHER PARTY SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORTING TO ANY FORM OF CLASS ACTION.
